BYLAW #709

A BYLAW TO AMEND OFFICIAL COMMUNITY PLAN BYLAW #669.

WHEREAS the Council of the Village of Montrose adopted an Official Community Plan in 2008;

AND WHEREAS the Official Community Plan establishes Council's policies on land use matters;

AND WHEREAS Council wishes to amend the Official Community Plan Schedule 'B' – Land Use Map;

AND WHEREAS Council wishes to amend the Official Community Plan Schedule 'C' – Development Permit Areas Map;

NOW THEREFORE, the Council of the Village of Montrose, in open meeting assembled, ENACTS AS FOLLOWS:

SHORT TITLE

1. (1) This Bylaw may be cited as the **"OFFICIAL COMMUNITY PLAN AMENDMENT** BYLAW – SCHEDULES 'B' & 'C' (2013)".

from the Multiple Unit Residential Development Permit Area to the Core Commercial Development Permit Area.

ENACTMENT and REPEAL

- 4. (1) If any section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the part that is invalid shall not affect the validity of the remainder.
 - (2) This Bylaw shall come into full force and effect on the final adoption thereof.
