Ms. Proulx advised of the impact this funding cut has on local family daycare centres. Ms. Proulx also stated ongoing issues associated with the decision to reduce Daycare Operating Grants.

A question and answer period followed the presentation. Council thanked Ms. Lavery and Ms. Proulx for their presentation.
