	<u>Skateboard Park</u>
Choices	Administrator presented a memorandum to outline three choices Council has with respect to the proposed skateboard park. The choices included rejecting the proposal, approving the proposal, or approving the proposal subject to specific conditions.
Debate	Open discussion on experiences in other locations with skateboard parks. Issues of concern included noise and the attraction such facilities tend to have to people displaying little concern for neighbours.

	<ul> <li>c) that security measures, including fencing and lockable gates be incorporated in the design of the park,</li> </ul>
	<ul> <li>d) that sound reducing features be incorporated in the design of the park,</li> </ul>
	<ul> <li>e) that the society submit the conceptual engineering designs and specifications to Council for review of the criteria stipulated by Council before proceeding to the final design stage,</li> </ul>
	<li>f) that the society submit the final design to Council for approval of the conditional design criteria set by Council.</li>

## SCHOOL STRATEGY

Board Presentation Council directed that a presentation paper be prepared for the April 24, 2002, meeting with the School Board. Council directed that the school board presentation address the following points:

- a) Council's position as established in the OCP,
- b) the enrolment and financial position of Montrose Elementary School based on school board data,
- c) a proposal for the Village to assume a responsibility in the operation and maintenance of Montrose Elementary School, and
- d) a proposal to transfer the ownership of the school to the Village in the event that the Board decides to close the school.
