Mayor Danchuk

Committee Report

Mayor Danchuk reported the following:

- 1) Attended a LCCDT meeting on June 13 to share information and discuss strategies to have FortisBC rates lowered. FortisBC was invited to the meeting where it was learned that FortisBC residential rates are 20% higher than BC Hydro residential rates. A committee has been formed and will participate in a conference call with Okanagan municipalities to discuss further strategies to communicate the issues to the ministry and request that these rates are reconsidered.
- 2) Attended a West Kootenay Economic Development Dialogue session in Castlegar where regional municipalities gathered as a unified voice for regional economic development. Castlegar and Nelson both shared success stories for all communities to consider and learn from. City of Trail representatives did not attend.
- 3) Updated Council on the CBT Lower Columbia Community Directed Funds initiative. LCCDT will be administering the initiative with a meeting to be held on July 16 to develop a Terms of Reference and form a Steering Committee.
- 4) Mayor Danchuk requested that Council reconsider membership in the BC Association of Community Response Networks.
 - Councillor Cook stated her intention to participate as a member.
- 5) Mayor Danchuk discussed a request received from Area A Director Grieve regarding support for Area A residents who would be affected financially by the proposed Trail Boundary Extension.
